If a team planned to enter a deleted division, that team may play in another division or receive a refund minus your deposit, or transfer the balance to another NABA/Slammers Showcase Tournament, provided it is at least 5 days prior to check-in. The NABA & Slammers also reserves the right to make changes to the rules or make changes in prizes and/or giveaways (but with a substitute of equal or greater value), which would then be effective upon notice to the teams participating in the tournament.
